#### Responsibilities

- Participate in the planning and design of activities/lessons for summer camp
- Lead, take responsibility, and participate in camp activities
- Guide the social-emotional learning of neurodivergent and/or disabled youth
- Greet, escort, and monitor youth throughout the camp day, assuring their safety
- Support youth to transition from one camp space or activity to another
- Identify needed supplies and resources and report to the program manager
- Lead team debriefs and team training sessions
- Assist in actively recruiting students
- Take daily attendance of participants and report to the program manager
- Prepare snacks, set up supplies and break down supplies as needed
- Communicate effectively and respectfully with youth, families, school and program partner staff, and colleagues
- Follow program policies and procedures to create safe, supportive, interactive and engaging, learning environments

- Bachelor's degree, or equivalent, in special education, youth development, or related field
- 3+ years of experience working with neurodivergent and/or disabled youth
- 2+ years of experience leading a team
- Knowledge of best practices in out-of-school-time programs to build safe, supportive, interactive, and engaging learning environments
- Ability to set up and move supplies
- Ability to escort children to and from camp areas
- Ability to monitor and track campers throughout the day
- Ability to pass a Sterling background check
- Ability to perform all tasks identified in this job description
